

Decision of RTA, Pathanamthitta : Meeting held on 29.03.2017

DECISIONS**Item No.1**

Heard the learned Counsel represented the applicant. This is an application for fresh regular stage carriage permit on the route Elavumthitta-Valiyakavu(via) Muttathukonam, Prakkanam, Pallam, Karimpanakuzhi, Makkamkunnu, Stadium Junction, MuthootAbanJn, Pathanamthitta, SP Office Jn, Vettipram, Kadammanitta, Alumkal, Valiyakulam, Kozhanchery, Cherukolpuzha, Mathappara, Thekumkal, Plankamon, Poovanmala, Menamthottam, Mamukku, Ittiyappara Bus stand, Mamukku, Chirakkalpadi, and Kadavupuzha. KSRTC has strongly objected the issuance of the permit. The Secretary RTA has reported that a distance of 6.2Kms from Makkamkunnu to Prakkanam is virgin portion and Road fitness certificate has not obtained from the concerned authorities. RTA held on 28.09.2016 adjourned the matter with a direction to secretary RTA to obtain a specific report regarding the Road fitness certificate from Makkamkunnu to Prakkanam and place the matter before next RTA.

RTA held on 30.01.2017 considered the application. The applicant produced Road Fitness Certificate from PWD Authorities which stated that the Muttukudukka - Prakkanam Road is fit for Stage Carriage Services. He produced another Certificate from Engineering Division of the Pathanamthitta Municipality which also proves the fitness of the Makkamkunnu - Karimpanamkuzhi- Punnalathpadi road for stage carriage services. The report from MVI, Pathanamthitta stated that the length of the route portion from Kumbazhathupadi to Puthenpeedika is 0.9km and the road is concreted to a width of 3 meters. KSRTC and other operators raised only timing objection and the overlapping is in the permissible limit of 4.06%. The application was adjourned for want of Road fitness Certificate from concerned authorities and Secretary, RTA, is directed to ascertain the width of the road from Kumbazhathupadi to Puthenpeedika that whether it is suitable for heavy stage carriage services by

conducting a joint inspection with PWD authorities, and place the matter before the next RTA.

The matter is again placed on the RTA held on 29.03.2017 with the detailed report of the field officer and the report stated that 200metres from Puthenpeedika end is tarred and the width of this portion is 8 meters. The un tarred portion in this part is on the same level as that of the road. In the remaining 700 metres of the route, width of the concreted portion is about 3 metres. The electric posts are standing near the concreted portion. In some of the Road Curves drainages are found with a depth of 2 feet.

Considering the above facts, for the beneficial of the travelling public **granted** fresh regular Stage carriage permit for **suitable LMV Stage carriage having seating capacity up to 28 in all**, on the route Elavumthitta – Valiyakavu(via)Muttathukonam, Prakkanam, Pallam, Karimpanakuzhi, Makkamkunnu, Stadium Junction, MuthootAbanJn, Pathanamthitta, SP Office Jn, Vettipram, Kadammanitta, Alumkal, Valiyakulam, Kozhanchery, Cherukolpuzha, Mathappara, Thekumkal, Plankamon, Poovanmala, Menamthottam, Mamukku, Ittiyappara Bus stand, Mamukku, Chirakkalpadi, and Kadavupuzha as ordinary service subject to the settlement of timings.

Item No.2

Heard the learned Counsel represented the applicant. This is an application for Fresh Stage carriage permit on the route **Edamon –Adichipuzha** (via) Vakamukku, Vechoochira, Mattannoorkara, Erumely, Vechoochira, Mannadisala, Kadumeenchira, Athikkayam, Kakkadumon, Ranny, Athikkayam, Thoniknkadavu, Perumthenaruvi, Thonikkadavu, Ranny, Jandayikkal, Valiyakulam for a suitable stage carriage for 5 years. The field officer reported that the Total overlapping in the notified routes is 4.02 % and is within the permissible limit. This is an inter district route having a route length of 96.9 kms in which 86.9 kms lies in Pathanamathitta Dist. and 5 km in Kottayam Dist. KSRTC and other operators strongly objected the issuance of the Permit that sufficient service is not provided between Perumthenaruvy and Adichipuzha which is an ill served route. KSRTC also alleged that only single trip is provided between Perumthenaruvi and Adichipuzha with intention to overcome the overlapping on the notified routes. Hence Secretary is directed to obtain a specific report in this regards with direction to the applicant to submit a modified proposal with adequate service between Perumthenaruvi and Adichipuzha. Secretary, RTA is also directed to seek concurrence from the Sister RTA, Kottayam for the portion lying in the Kottayam Dist. Hence **adjourned**.

Item No.3

Heard the learned Counsel represented the applicant. This is an application application for grant of fresh regular stage carriage permit on the route **Malayalappuzha - Pandalam (Via)**Pathisery, MylapraPallipadi SP Office, Pathanamthitta, Muthoot Hospital, Kayson Petrol Pump Jn (Gas Agency), MakkamkunnuKurusu, Santhoshmukku, PallomMuttukudukka, Prakkaanam, Muttathukonam, Elavumthitta, Ramanchira, Ampalakkadavu, Thumpamon for the Stage Carriage **KL-03-N-1566** for a period of 5 years. The field officer reported that the total overlapping is 3.2 % of the total route length and there is a virgin portion of 400 Meters from Kayson Petrol Pump Jn. to MakkamkunnuKurusu. But Road fitness Certificate has not been produced from the concerned authorities that whether the virgin portion is suitable for Stage carriage Services. The field officer also reported that the route portion from Pathissery Jn. to Kumbazha North Jn. have not enough width to accommodate Heavy Stage carriage Services. KSRTC and other operators strongly objected the grant of fresh permit. Hence Secretary, RTA is directed to obtain a specific report regarding the virgin portion and place the matter before the next RTA. Secretary, RTA is also directed that whether the entire route is suitable for Heavy Stage carriage Services or not. Hence **adjourned**.

Item No.4

Heard the learned counsel represented the applicant. This is an application for Fresh Stage carriage permit on the route **Athumpukulam - Pathanathitta** (via) Payyanamon, Chankoor Jn, Murinjamangalam Temple, Konni,MuringamangalamTemple,Anakuthy, Kummannoor, Muringamangalam Temple, Konni, ElakollurMahadeva temple, Chappathupadi, Jolly Jn, (Lakkoorvanchipadi), Lakkoor , Poomkavu, PramadamNethaji school, Pramadamvanchipadi, Azhoor petrol pump, St. Peters Jn. for a suitable stage carriage for 5 years.This is an intra district route having a route length of 27.4 kms .The field officer reported that the total overlapping is 4.38 % of the total route length and 1.9 km from Chappathupadi to Jolly Jn is virgin portion . Road fitness certificate has been produced only on 29.03.2017. KSRTC and other operators objected the grant of fresh permit. On perusal of the file it is learned that sufficient number of services are not provided between Kummannoor ,Konny and Pathanamthitta. Hence Secretary, RTA is directed to obtain a modified proposal with sufficient number of trips between Kummannoor ,Konny and Pathanamthitta for the beneficial of the travelling public of that sector and place the matter before the next RTA. Secretary, RTA is also directed to report the exact route length of the route Athumpukulam – Pathanamthitta. Hence **adjourned**.

Item No.5

Heard the learned counsel represented the applicant .This is an application for application for the variation of the permit ie the curtailment of the Last trip from Thiruvalla to Chathankerykadavu in respect of the Stage Carriage KL-05-W-5297 conducting service on the route **Perunna Bus stand – ChathamkeryKadavu** (via) Nalukody, Paipadu,Thiruvalla, Kavumbhagom, Peringara, Chathenkery. The field officer reported thatafter the Last trip of the vehicle to Chathamkerykadavu other stage carriages are conducting services to Chathankerykadavu at 6.57 PM and 8.05 PM and back to Thiruvalla at 7.30 PM and 7.45 PM. The field officer also reported that the application is considerable. KSRTC and other operators raised no objections and no other complaints received from the public. Hence the variation **Granted** subject to the settlement of timings as per D3/875/STA/2005 dated 08/11/2011.

Item No.6

Heard the learned counsel represented the applicant. This is an application application for renewal of permit in respect of S/C **KL-03-M-567** on the route route **KOZHENCHERRY-MELEKOTTAMONPARA** (VIA) Kadamanitta, Pathanamthitta, Vadasserikkara, Maniyar, Chittar and Seethathode , for a further period of 5 years.

Heard the learned counsel appeared for the applicant and perused the report of the Secretary RTA and found the permit was issued prior to 09.05.2006. KSRTC raised no objection , No STU application has pending.

This permit was issued before 14/07/2009 vide Notification No.8/2017
